Speakers: Dr. Michael E. Elta

A joint venture between the O.I.S. division of Guardian Industries and the University of Michigan is in progress for the development and manufacture of large Liquid Crystal Displays. Dr. Elta will discuss some of the plans and the involvement of the University. He will give a semi-technical discussion of the liquid crystal, how it differs from other flat panel displays, and its possible uses in HDTV.

It's not a matter of if data compression will be used in broadcasting!

DAB and HDTV are on their way. Broadcasting as we've known it in the past is becoming history. Digital compression or more correctly digital data reduction *will* be part of both radio and television broadcasting in the near future. Many broadcasters are using it now for commercial and satellite delivery. Skip will discuss the basic workings of digital audio data reduction systems and compare the merit of different approaches. Aural demonstrations will be played. Problems caused by the application of multiple generations of such processing will also be discussed and demonstrated. Finally, applications of this technology will be considered, including digital audio storage, wired transmission and broadcasting.

Our presenter is Skip Pizzi, Technical Editor of *Broadcast Engineering* magazine and author of *Digital Radio Basics* both from Intertec Publishing Corporation. Recent projects have included subjective testing of digital audio compression systems and a study of data encryption systems for the Public Radio Satellite Sytems. He has also conducted a series of seminars on new broadcast technologies for the CBC.

Mr. Pizzi is a contributing author to *The NAB Engineering Handbook* and to *Sound Reporting*, a radio production/journalism text. His work has appeared in more than a dozen other magazines since the early 1980s. Skip is also a consultant and trainer with clients throughout the U.S. and Canada. He spent 13 years at National Public Radio. His background includes work in sound reinforcement, music, theater and local radio. He studied physics, international economics and fine arts at Georgetown University, earning a B.A. in 1975. Skip is a member of the AES and the SBE. In 1990 he received the AES *Board of Governors Award*.
